

### **Basis** of the Council

Confessing Jesus Christ as only Saviour and Sovereign Lord over all of life, we affirm the basis of the fellowship of Presbyterian and Reformed Churches to be full commitment to the Bible in its entirety as the Word of God written, without error in all its parts and to its teachings as set forth in the Heidelberg Catechism, the Belgic Confession, the Canons of Dort, the Westminster Confession of faith, and the Westminster Larger and Shorter catechisms.

### **Purpose** of the Council

We regard this basis of fellowship as warrant for the establishment of a formal relationship of the nature of a council, that is, a fellowship that enables the Member Churches to advise, counsel, and cooperate in various matters with one another and hold out before each other the desirability and need for organic union of churches that are of like faith and practice.
