The 47<sup>th</sup> annual meeting of NAPARC is scheduled for **November 8-10**, **2022** to be held at the **Sonesta Atlanta Airport North** hotel (the *North* is important in the name to differentiate it from other Sonesta hotels in the area). The hotel is located at 1325 Virginia Avenue, Atlanta, GA 30344. The hotel is about a five minute drive from Atlanta's Hartsfield-Jackson International Airport, with a complimentary airport shuttle every 30 minutes without a reservation. A special group room rate of \$129 for either a single king or two doubles is available **until 5:00 p.m. October 24.** The rate includes buffet breakfast for up to two people per room. Self-parking is extra at 50% off the current rate. The current rate is \$18 and subject to change. Reserve your lodging *here*. The Presbyterian Church in America will host the meeting at the hotel.

Registration is on-line <u>here</u> and due **September 27**. One person should register for your whole group. When you register, be prepared with the names of all your delegates (up to four delegates), their contact information, the names of other non-delegates in your group, the number of meals your group plans to take, and any dietary restrictions. .

The *Suggested Form for Member Church Reports* is being sent with this notice as a separate document in MSWord for easy editing. Please complete it and return it to the undersigned by **September 27**.

All documents and information germane to the preparation of a docket for this meeting (church reports, committee reports, delegate information, replacement Interim Committee appointees, business items etc.) *must* be in the hands of the undersigned "at least six weeks prior to the meeting date," i.e., on or before **September 27.** Late submissions will be brought before the Interim Committee for approval before being placed on the docket (By-laws IV:2).

The **annual dues for 2022 are \$1,000 per church** (2021 Minutes Art. 20.A.1, page 9). An invoice will be forthcoming to each member Church from our Treasurer, Rev. Todd De Rooy.
