A BRIEF HISTORY OF NAPARC

(Excerpted from the Report of the NAPARC Committee of Review to the 38th (2012) Meeting of NAPARC)

Taking note of NAPARC's founding in 1975 (and that 2010 would accordingly be the thirty-fifth anniversary of that event)—and observing that, even as God has continued to be gracious and merciful to His covenant people over the decades, fresh opportunities for and challenges to faithfulness are ripening for NAPARC (including the more than doubling of the number of Member Churches¹ in recent years), as it seeks to advance the fellowship of Presbyterian and Reformed churches in the cause of Christ—the 35th (2009) Meeting of NAPARC determined "to appoint a Committee of Review² consisting of five members to *review the* [C]onstitution, goals, activities, and meetings of NAPARC and to report next year."

I BRIEF HISTORY OF NAPARC

A. Formation

The formation of NAPARC perhaps might be traceable to an initiative undertaken by *The Presbyterian Review*⁴ to invite several Reformed denominations (or groups within Presbyterian and Reformed denominations) to send representatives to a meeting for the purpose of opening channels of communication between them. The first such meeting was in <u>December 1969</u>, and was followed up by a second meeting in March 1970. Individuals representing the following groups or denominations were present at one or both meetings: ARPC, CRCNA, Conservative Congregational Christian Conference, PCUS, Reformed Church in America, Reformed Episcopal Church, RPCES, RPCNA, and United Presbyterian Church in the USA.⁵

A further meeting of individuals from these groups was held in <u>October 1970</u>, during which the National Presbyterian and Reformed Fellowship (NPRF) was established—as a fellowship of individuals, not of churches—and a steering committee was erected to develop recommendations concerning the purpose, principles of fellowship, organization plans, etc., of the NPRF. In <u>April 1971</u>, the steering committee proposed a constitution⁶ for the NPRF, and the incorporation and adoption of bylaws was announced in its <u>October 1971</u> meeting.

The purpose of the [NPRF] in this crisis is to join for encouragement and mutual assistance those who seek in our time the unity of a pure witness to the Word of God and the testimony of Jesus

At its meeting in <u>October 1972</u>, the NPRF adopted a resolution which included the following:

God's grace has kindled in our time a new zeal for an uncompromising witness to the whole counsel of God revealed in Scripture and summarized in the historic creeds of the Presbyterian and Reformed churches. New devotion to Jesus Christ as the only Lord and King of His church has quickened concern to maintain the purity of the gospel as the great mark of the church and to proclaim its saving truth in these latter days.

We, of the [NPRF], in our experience of God's work in our time, have come to recognize the necessity of a common bond of counsel among those churches, both established and emerging, that share this conviction and vision.

We therefore have determined to issue a call to representatives of such churches to explore together the convoking of a national Synod of genuinely Presbyterian and reformed [sic] churches.

We are bold to issue this call in the conviction that the full spiritual authority exercised in the name of Christ in particular churches (whether denominational or temporarily independent) does not prevent but rather requires taking counsel together with respect to the national service and witness of these churches. *A national synod that did not constitute organic union of its participating churches could nevertheless provide a true spiritual bond for the furthering of the worship and work of these churches and of the church of Christ in America.*

To this end we call a meeting for this purpose [in January 1973 of the correspondence or fraternal relations committees of the Presbyterian and Reformed churches]....⁷

In <u>February 1974</u>, there was an informal meeting of a group of individuals from the CRCNA, OPC, PCA, RPCES, and RPCNA, who were attending a NPRF meeting,⁸ during which the group agreed on the following statement:

The sense of this meeting is that it would be desirable to *convoke a plenary session of the full interchurch relations committees* of the respective denominations to explore closer relationships between the denominations.⁹

The meeting of the interchurch relations committees of the five churches¹⁰ was held in <u>October 1974</u>. Three questions were put forward for discussion:

- 1) What developments in the world situation, and particularly in the United States, are likely to affect the life of the Churches in their relations with one another?
- 2) What are the greatest dangers (hindrances, hangups [sic]) to the accomplishment of our joint objectives?

3) What are the greatest opportunities (possibilities) for joint accomplishments?¹¹

And after a period of small group discussions, the following correlation of the proposals from the small groups was presented:

- I. Major Proposals
 - A. That there be a federation of Presbyterian and Reformed churches (to include the coordination of agencies and the holding of consultative assemblies)
 - B. That the ultimate goal be a union into one church
- II. Elements of cooperation, for immediate adoption, looking forward to federation
 - 1. The setting up of a clearing house, for information
 - 2. The publishing of a directory of cooperating churches
 - 3. The coordinating of matters now under study in the denominations
 - 4. The meeting of executives and/or five representatives of each agency
 - 5. The coordination of relief services
 - 6. The encouragement of cooperative structures at the presbytery level
 - 7. The striving for cooperation in education: Christian schools
 - 8. The scheduling of annual church assemblies together, starting 1977
- III. General Proposals
 - 1. To encourage pulpit exchanges
 - 2. To carry out theological consultations
- IV. Preliminary steps, involving the joint fraternal committees
 - 1. That the committees of the respective churches meet annually
 - 2. That each denomination determine which bodies should be included in the future meetings, and the bases on which such determination is made¹²

A subcommittee (composed of two members from each of the five churches' interchurch relations committees) was then established "to prepare a plan for cooperation and relationship of the respective churches" and to report back within six months "for possible recommendation to the parent bodies." It was also agreed to invite the RCUS to send representatives to participate in future meetings. A draft of a constitution and bylaws for the new body, named "The North American Presbyterian and Reformed Council," was appended to the *Minutes* of the meeting.

In <u>January 1975</u>, members of the interchurch relations committees of the five churches (with both ARPC and RCUS committee members in attendance as observers) met and determined "to propose to the respective parent bodies the creation of a North American Presbyterian and Reformed Council (NAPARC)." ¹⁴ It was also determined:

• To recommend to the respective parent bodies that they accept the Basis of this Council and its Constitution and Bylaws as adopted at this meeting, and agree to the establishment of and participation in the North American Presbyterian and Reformed Council;

- To recommend to the various major assemblies that two members and/or executives of each of the following church agencies meet regularly for mutual sharing of plans and consultation: Foreign Missions, Home Missions (Church Extension, Evangelism, etc.), Relief, Church School Education;
- That each church consider inviting two members from each of the Council's churches to be present as fraternal delegates to the major assemblies throughout the sessions of the assemblies with advisory status and the privilege of the floor.¹⁵

On October 31 – November 1, 1975, the delegates of the five constituent churches (CRCNA, OPC, PCA, RPCES, and RPCNA, with representatives from the ARPC and the RCUS present as observers) met in Beaver Falls, Pennsylvania, heard the reports of the affirmative actions of the major assemblies, and RESOLVED—

That the delegates of the said churches named above do hereby, by the authority vested in them by their churches, *declare the North American Presbyterian and Reformed Council to be duly constituted*. To God be the glory. Amen.¹⁶

The Proposed Agenda for the meeting included a list of study subjects (both those already completed and ready to be shared and those on which consultation and study is desired) and a list of areas of cooperation (both those already engaged in and those which should be explored).¹⁷ The meeting also determined to "call for a prolonged Concert of Prayer on the part of the Council's Member Churches"¹⁸

B. Membership

Viewed chronologically by date of reception,¹⁹ seven years would pass after NAPARC was formed with five Member Churches before another two members would be added (and one would cease by virtue of its union with another member); then thirteen years would elapse before another member would be added; then, another seven years later, the membership of one of the founding members would be terminated; and finally, over the course of the seven years 2003–2009, the membership of NAPARC would double with the addition of six new members (at the rate of almost one new member per year).

C. Actions and Decisions²⁰

The adopted Basis of NAPARC contemplates two primary areas of endeavor among the constituent churches:

- Advise, counsel, and cooperate in various matters with one another, and
- Hold out before each other the desirability and need for organic union of churches that are of like faith and practice.²¹
- **1. Advise, Counsel, and Cooperate.** Article IV of NAPARC's *Constitution* provides:

It is understood that all actions and decisions taken are *advisory* in character and in no way curtail or restrict the autonomy of the member bodies.

Early on, as it considered its "role of authority"²² in sponsoring conferences, NAPARC added to its *Bylaws* the following section pertaining to the publicizing of conference materials and conclusions, and to its speaking for the Member Churches:

The materials and conclusions are to be considered the property of the several member churches, and may be used and publicized by them only in their own name unless approved by other member churches also; joint publicity of the results of the Study Committee or Conferences shall be by the churches themselves as distinguished from

publicity by NAPARC which is consultative rather than policy making. Neither NAPARC nor NAPARC Study Committees or Conferences may speak for the member churches.²³

And in 2007, while discussing the matter of women in the military, NAPARC agreed "that NAPARC respond to inquiries regarding NAPARC's position on the matter by listing the relevant adopted statements of the Member Churches including their grounds."²⁴

a. Ecclesiastical Fellowship. To help its Member Churches achieve a degree of uniformity in their bilateral relationships with one another, NAPARC, in its second meeting, adopted the following proposal:

That the CRC be thanked for its development of the concept of "Churches in Ecclesiastical Fellowship" and that a committee, composed of representatives of each constituent body of the Council, be named to consider this concept in a broader context with a view to recommending a church relationship policy that would be suitable for all the churches ...²⁵

The following year, NAPARC adopted the recommendation of its committee:

That NAPARC recommend the following church relationship policy to its constituent churches:

- 1. That we acknowledge the Scriptural mandate (Ephesians 4) to enter into Ecclesiastical Fellowship where it is consistent with Scriptural unity and truth as a visible demonstration of the unity of the church both to the church and to the world.
- 2. That we define Ecclesiastical Fellowship for NAPARC Churches as follows: Ecclesiastical Fellowship is a relationship in which the churches involved are Reformed in their confessional standards, church order and church life though there may be such differences between them that union is not possible at this time and there might be considerable need for mutual concern and admonition.
- 3. That where churches enter into Ecclesiastical Fellowship with other Reformed churches, that relationship be implemented where possible and desirable by:
 - a. Exchange of fraternal delegates at major assemblies
 - b. Occasional pulpit fellowship (by local option)
 - c. Intercommunion (regulated by each session/consistory)
 - d. Joint action in areas of common responsibility
 - e. Communication on issues of joint concern
 - f. The exercise of mutual concern and admonition with a view to promoting the fundamentals of Christian unity.
- 4. That we mutually recognize that the decision to enter into or withdraw from Ecclesiastical Fellowship with another Reformed church shall be decided by each church on an individual basis.²⁶

And it is your Committee's understanding that several of the NAPARC Member Churches have incorporated much of that recommendation into the structure of their own bilateral relationships with other churches.

- b. Member Church Agencies' Consultations. Since the amendment to the article in the *Bylaws* pertaining to committees and conferences in 1978,²⁷ the term "consultation" has been associated with the "annual consultations between agencies of the various NAPARC churches,"²⁸ while the term "conference" has been associated with gatherings on a more *ad hoc* basis "on subjects of mutual concern to which all Member Churches are urged to send representatives."²⁹ While the *Minutes* of its meetings reflect annual consultations of the agencies pertaining to foreign missions, home missions, Christian education, and diaconal ministries on a fairly regular basis during NAPARC's early years, the only consultations that have continued to meet regularly on an annual basis have been those of the foreign and home missions agencies³⁰—and those consultations have done much to foster greater cooperation among several of the Member Churches in the work of missions.
- c. NAPARC Study Committees and Conferences. In addition to the Committee on Ecclesiastical Fellowship, NAPARC has established the following committees or conferences to study various matters of mutual concern, including:
 - (1976) Office in the church³¹
 - (1976) Theological education
 - (1976) Racial issues
 - (1977) Divorce
 - (1979) Hermeneutics³²

- (1983) Pornography and obscenity
- (1984) Receiving members under discipline
- (1993) Review relevant CRCNA documents that give the grounds for the opening of the office of elder to women
- (1999) Women in the military
- (2000) Collate the Member Churches' information and develop mutually agreeable definition of "organic union" (2001)

In 1984 it was agreed "that the Council strongly urge the Member Churches that when they plan a study of doctrinal or ethical matters, that they consider asking other NAPARC churches to join them in the study, it being understood that each participating delegation would make its own recommendations to its church."³³

d. Sharing of Major Reports of Member Churches' Study Committees. At the very first meeting of NAPARC, the meeting determined:

- That each delegation should prepare and submit to the Council at its next meeting a
 list of the completed major reports of its denomination, with references to where it
 may be found, and that each delegation determine how far back to go
 chronologically and what constitutes a "major" report;
- That each delegation should furnish to the Council at its next meeting a list of topics that are currently under study in its denomination and that these lists be updated annually by each interchurch relations committee.³⁴

In 1981 it was agreed "that the study reports of the various Member Churches that are deemed to be of value to all of NAPARC be circulated to the sister churches." The following year, the *Minutes* record:

That since the previously adopted action of the Council—"That study reports of the various member Churches be circulated to sister Churches" (M7NAPARC, #12)—has not been implemented with great satisfaction, that the following procedure for its effective and orderly implementation be recommended to all Churches:

- a. Each denomination report annually to the [sic] NAPARC the subjects of that year's study reports, and where they may be found.
- b. The Secretary of NAPARC compile a list of such reports alphabetically by subject, update it annually, and transmit it to the Stated Clerk of each member denomination.
- c. The Stated Clerk of each denomination send the list to each session/consistory and minister of his Church. $^{36}\,$

The *Minutes* of NAPARC's 1983 meeting are silent on the matter, but one of the interchurch relations committees of a Member Church included the following in its report to its general assembly: "The list of studies made by NAPARC churches that was distributed at the 1983

NAPARC meeting is below...."³⁷ Your Committee could find no reference to a cumulative topical listing since then.

While most of the annual reports of the Member Churches to NAPARC are careful to include a listing of ongoing and just completed study papers, NAPARC's efforts to produce a cumulative topical listing of the major reports of the Member Churches has proved elusive. There has been some discussion within the NAPARC Website Committee of including such a listing (perhaps one day, together with links to digitized copies of the study papers themselves) on the website, when such a listing might become available.

e. Establishment of Website. In 2000 NAPARC approved a recommendation to register the NAPARC domain name and develop a website that would contain NAPARC's Constitution and Bylaws and links to the websites of the Member Churches. In 2004 a Website Committee was established,³⁸ and in 2007 the Website Committee was authorized to appoint a webmaster to work under its oversight.³⁹ In 2010 NAPARC.org underwent a complete redesign, and digitized copies of the Minutes of the 1st–35th (1975–2009) Meetings of NAPARC, the Constitution and Bylaws, the "Golden Rule" Comity Agreement, and the NAPARC Agreement on Transfer of Members and Congregations were posted for download; also added was contact information for the Member Churches' world missions, home missions, Christian education, and diaconal ministries agencies, as well as for the major assemblies' stated clerks, and the dates and venues of the major assemblies.

f. Commemoration of Anniversaries of Events in Reformed Church History. In its thirty-six years of existence, NAPARC has been involved in planning commemorations of:

- 1993 the 350th anniversary of the seating of the Westminster Assembly
- 2009 the 500th anniversary of the birth of John Calvin.

And in 2007, NAPARC made a gift to St-Marc's Church (ERQ) to assist it in promoting Huguenot history as part of the 400th anniversary of the founding of Quebec City. 40

2. Organic Union. Although most of the endeavors undertaken by NAPARC over the past thirty-six years may seem to be more directly related to the first area, there were some concrete measures undertaken—most notably the planning for concurrent major assemblies of the Member Churches, all at Calvin College in Grand Rapids, in 1978, 1982, and 1987—to press on towards the organic union of Member Churches. In God's providence, only one union between Member Churches (the RPCES joined and was received into the PCA in 1982) has come to fruition; two other attempts at church union (between the OPC and the PCA in 1981 and 1986) were approved by one or both of the parties' major assemblies, but ultimately failed. Since then, while exploratory talks regarding union with another member of NAPARC may have been authorized by one or both of the contemplated parties' major assemblies, to the

best of your Committee's knowledge none have progressed to the point where there has been even a unilateral approval by any member's major assembly of a union with another Member Church.⁴¹

In 1998 the Member Churches were requested to "discuss and draw up concrete proposals regarding how NAPARC can fulfill its 'Purpose and Function' (see NAPARC *Constitution* III) for discussion at the 1999 NAPARC meeting"⁴²; and in 1999, NAPARC adopted the following:

We are grateful for the bonds of the gospel and the Reformed Faith that unite us. In the light of the "II. Basis of the Council" (*Constitution of NAPARC*) and in order that all NAPARC member churches may be more fully aware of the unique characteristics of each member church, we recommend that each member church discern and enumerate those issues of belief, practice, and government that, to the best of their knowledge, distinguish them from other NAPARC churches, and submit a report to NAPARC, no later than October 3, 2000, so that NAPARC may evaluate the Biblical and confessional basis for such distinctive positions and *the degree to which these issues necessitate continued separation*.⁴³

In 2003 a committee appointed to collate the various reports⁴⁴ presented its tabulation of the *Similarities and Differences Among NAPARC Churches* in chart form,⁴⁵ together with the following definition of "organic union," which was adopted:

Organic union is defined as two or more NAPARC Churches joining their diverse gifts, heritage and calling on the basis of the Scriptural mandate (Ephesians 4:1–16; Acts 15:1–16:5; John 17; 1 Corinthians 12:12–31) to form one church by uniting together in theology, polity and ministry. This would require the eventual integration of church courts and administrative and legal structures.⁴⁶
